### Utilization agreement

### **1. Collection, processing, utilization and passing on of personal data**

### **2. Right to be informed**

### **3. Consent**

Erbe is entitled to collect and process the above-named data for the purposes listed above and to utilize them for purposes of its own. The user expressly consents to this by confirming the terms of use when logging on to the services.

### **4. Right of revocation and right of objection**

Insofar as we use data for a purpose that, according to the legal regulations, requires your consent, we will always ask you for your express consent and will record your consent in accordance with the applicable regulations under data protection law.

As laid down in §35 BDSG (Federal Data Protection Act), you can have your data that have been collected by us blocked, corrected or deleted at any time. You have the right to revoke in writing the consent granted to us for data collection, processing and utilization without giving any reason.
